1. Granting rights

The author/editor transfers to the Federal Agency for Nature Conservation the non-exclusive, free-of-charge rights, unrestricted in terms of time, content and location, to store the above-mentioned publication electronically and to make it publicly accessible in the BfN- *e*-dition repository. The right applies to all known and not yet known types of use.

The author/editor remains free to dispose of his/her work in other ways as long as this does not involve any restriction of the rights granted to the Federal Agency for Nature Conservation in this contract.

2. Ownership rights

The author/editor assures that the document(s) do not violate any legal regulations, official decrees, or other rights of third parties. He/she also assures that she/he is entitled to dispose the copyright usage rights to his/her work and that he/she has not yet made any disposition that conflicts with the rights granted in this contract. He/she is responsible for the content of the document(s). If he/she becomes aware of the existence or emergence of legal obstacles, he/she shall inform the Federal Agency for Nature Conservation in writing.

3. Copyright declaration

The author assures that he/she has the copyright usage rights to all parts of the work and that the rights of third parties, in particular copyrights and personal rights of third parties, are not violated by the publication. This also applies to the text, images, or other templates provided by him/her. He/she grants exemption to the Federal Agency for Nature Conservation for any claims for damages for which he/she is responsible due to violations of copyright, usage rights, trademark rights, or other rights of third parties. The author/editor guarantees compliance with applicable data protection law.

4. Team of authors

In the case of several authors, signature of this contract is also carried out on behalf of all other authors who have been informed about the content of this declaration and who also agree to it.

5. Meta data

The Federal Agency for Nature Conservation may, if necessary, change and/or complete the metadata provided by the author/editor. The document(s) provided by the author/editor may be changed by the Federal Agency for Nature Conservation if this is necessary for technical reasons.

6. Licence

The author/editor agrees that the work will be published under the terms of the Creative Commons Attribution No Derivatives 4.0 (or its updates) International (CC BY-ND 4.0).

7. Conversion consent

The Federal Agency for Nature Conservation is granted the permanent right to convert the data provided into other data formats for the purpose of long-term archiving.

8. Transfer of rights

The Federal Agency for Nature Conservation is entitled to pass on the electronic publication, including the associated metadata, to the German National Library and other institutions as part of the mandatory delivery process. They are also granted the right to make the metadata freely accessible and usable to anyone.

9. Duration of validity of the declaration of consent

This declaration of consent is valid for an unlimited period of time.

For compelling reasons, the document can be deleted by the Federal Agency for Nature Conservation at any time. Justification for this, for example for compelling legal reasons (plagiarism, accidental publication of trade secrets, etc.), will be given in writing by the Federal Agency for Nature Conservation or by the author. The author/editor will be charged any costs for the resulting work.

10. Collection and processing of personal data

Personal data of authors/editors are collected and processed by the Federal Office for Nature Conservation for the purpose of executing the contract (electronic long-term archiving and electronic publication of the above-mentioned work in the institutional repository BfN- e-dition). Data collection and processing is necessary to carry out this task (fulfilment of a contract or implementation of pre-contractual measures) and is based on Article 6(1)(b) of the General Data Protection Regulation (GDPR).
